CASINO ACT 1997 Section 44

Order Barring Person from Adelaide Casino
(By Consent)

I,

Request that Adelaide Casino exercise its power pursuant to section 44 of the *Casino Act 1997* to bar me from Adelaide Casino for an unlimited period, commencing today/...../.....

Declaration

I declare that I am the person named above and that I make this request of my own free will

I acknowledge the Adelaide Casino may exercise its power to make recommendations to the Liquor and Gambling Commissioner to further bar me should satisfactory evidence indicate that I am placing my own welfare, and/or the welfare of my dependants, at risk through gambling

I acknowledge that, by virtue of this order to bar me, I must not enter any area forming part of Adelaide Casino and that;

- (a) should I enter Adelaide Casino, I will be committing an offence, for which I may be prosecuted in court and fined up to \$2,500; and
- (b) should I enter or attempt to enter Adelaide Casino, Adelaide Casino staff or Police may use reasonable force to prevent me from entering, or to remove me from the premises

Adelaide Casino shall not be held responsible in any manner for not denying me access should I gain access by any means whatsoever

By my signature on this document, I acknowledge receipt of a true copy of this barring order

I acknowledge that I have a right to apply to the Commissioner within 14 days of the order for a review of the order to bar me from Adelaide Casino

Release

In consideration of Adelaide Casino's exercise of its power under section 44 of the *Casino Act 1997* I hereby:

- Release Adelaide Casino from any liability for any claim, action, suit and/or demand for compensation, damages or loss whatsoever made by me, on my behalf, or by any other person arising out of, or as a result of or in connection with;
 - my denial of access
 - my gaining access by any means whatsoever
- Indemnify Adelaide Casino in respect of any claim, action, suit and/or demand of any kind arising out of or in connection with my denial of access to Adelaide Casino or my gaining of access or breach by me of an obligation contained within this agreement

Obligation

By virtue of this agreement, I undertake to advise the staff of Adelaide Casino of my status as a barred person prior to passing through any entrance to Adelaide Casino premises

By virtue of this agreement, I undertake to contact management of the Adelaide Casino for the purpose of providing an updated photograph for the purposes of identifying me as a barred person on the third anniversary of the signing of this agreement, and on each third anniversary thereafter

Variation/Revocation of the Order

I acknowledge this barring will be effective for a minimum of 12 months from the date this barring is invoked. Only after the 12-month period has lapsed may I apply to have the order revoked

I acknowledge that should I desire to have this order to bar me from Adelaide Casino varied or revoked, I must apply in writing to the licensee of Adelaide Casino for such a variation or rescission

Inconsistency Provision

If any provision of this agreement is offensive and inconsistent with any statute, regulation or other edict having the force of law, then to the extent of that offence or inconsistency (and not otherwise) this agreement will be of no effect and the offensive or inconsistent provisions will be removed from the balance of this agreement, which balance will remain in operation

Order
