

Terms & Conditions – Fort Knox

1. Promoter is SKYCITY Adelaide Pty Ltd t/as Adelaide Casino of North Terrace, Adelaide, SA. A.B.N. 72 082 362 061 (hereafter referred to as 'Adelaide Casino'). SA Licence No. T09/3001.
2. The promotional period commences at 1pm on 04/01/10 and concludes at 7pm on 22/01/10.
3. The promotion is only available to gaming machine players, playing a Fort Knox Gaming Machine (defined as having visible credits) in Area A located on the ground floor in what is known as Southside at Adelaide Casino.
4. By entering into and participating in this promotion, each entrant fully and unconditionally agrees to and accepts these terms and conditions.
5. All promotional material including information on internal signage, list of terms and conditions and Casino License agreement forms part of the conditions of entry.
6. To take part in the promotion, customers must be playing a Fort Knox gaming machine in Area A of the Casino during the time periods of either 1pm-3pm or 5pm-7pm.
7. Every day of the promotional period, an Adelaide Casino staff member will hand out 1 entry ticket every 15 minutes during the 2 nominated time slots to each person spotted playing a Fort Knox gaming machine in area A. The customer must fill out the entry ticket and place it in the clearly marked receptacle that will be located close to the Fort Knox bank of machines in order to enter the promotion.
8. If the person playing Fort Knox in the time period that entry tickets are handed out is an Action Loyalty member they will receive 2 entry tickets.
9. At the end of each 2 hour window period (1pm-3pm or 5pm-7pm), all entry tickets in the receptacle will be thoroughly mixed and a winners name will be drawn at random. The daily draws will take place in Area A by an Adelaide Casino staff member at 3.15pm & 7.15pm. Once each draw has been completed, the tickets will be retained and emptied into a larger container, to allow a new batch of entry tickets to accumulate in the nominated receptacle for the draw applicable to the following 2 hour window.
10. The first eligible ticket drawn will entitle the winner to receive \$500 cash.
11. There will be 38 draws all up with the total prize value on offer being \$19,000 cash.
12. Any invalid (self barred, barred or otherwise) entry drawn will be void and another entry drawn.
13. In the event that the drawn entry is found to be illegible or ineligible, a subsequent ticket will be drawn and the prize awarded in accordance with these terms and conditions.

The prize will be available for collection from the Action Desk upon presentation of the letter, their Action Card and/or proof of identity. 17. All winners details will be advertised in the Public Notices section of the Adelaide Advertiser newspaper on 27th Jan 2010.
18. Employees of Adelaide Casino and companies associated with this promotion and their families are ineligible to enter.
19. Participation in the Promotion means acceptance of the Conditions of Entry and confirms acceptance to participate in any reasonable publicity or advertising that Adelaide Casino may request, including photographs and use of their image on the Adelaide Casino website.
20. Failure to observe the Conditions of Entry may result in disqualification.

Adelaide Casino shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for personal injury which is suffered or sustained as a result of taking any of the prizes, except for any liability which cannot be excluded by law.
